Spring Planning Forum: Making It Great Now

Making it Great Now is a full-day program offered at two locations within the state that focuses on revitalization strategies for Pennsylvania communities. The program will emphasize projects operating within short planning horizons using limited resources - strategies and methods that can be rapidly deployed, quickly implemented, and readily realized to advance community goals. The keynote speaker for both locations is *Andrew Howard, AICP of Team Better Block*, a leading expert in placemaking and transportation.

Andrew's experience in public and private sector planning and design has provided him an excellent perspective on city and regional issues. His work combines two important American traditions: entrepreneurship and the spirit of community. His overarching goal is to equip leaders to take action in their communities. As a Principal at Team Better Block he helps communities develop and organize their economic assets to build productive, resilient relationships across the public, private, and civil sectors. The Better Block concept is in practice in over fifty cities and three nations, and demonstrates how temporary improvements to a single block can build momentum for long-term financial, social, and environmental advancements.

The remainder of each day's program will be filled with a more local perspective – the “how to” and “hands on” of creative asset mobilization, organizational structure, community capacity building, institutional support, and civic engagement. Mayor John Fetterman of Braddock will present over lunch at the Indiana, PA location, while Mayor Ed Pawlowski and Representative Robert Freeman will present over lunch at the Allentown, PA location.
